

Prof. Dr. Ghaleb Rabab'ah Professor of Linguistics

Profile

Dr. Rabab'ah is a well-published and highly-cited professor of linguistics and applied linguistics. He has published more than 30 research articles in international and highly indexed ISI and Scopus journals. He is the most cited professor in the faculties of humanities and social sciences at the University of Jordan (According to Google Scholar: 558 citations and an i10-index of 12). He serves as an editorial board member of International Journal of Arabic – English Studies (IJAES), and the Jordan Journal of Modern Languages and Literature (JJMLL), and a reviewer for several international journals. Currently, he is a member of the University of Jordan Research Council.

Dr. Rabab'ah is the winner of three national and international awards and research grants. In September 2016, Dr. Rabab'ah won Abdul Hameed Shoman Award for Arab Researchers in Arts, Humanities, Social and Educational Sciences. He also won the Amy Mahan Research Award, given by Canada's International Development Research Center (IDRC) to assess the ICT impact on the Jordanian community (Period: 2009–2011). The results of the study were published in a book chapter published by MIT Press, *Public Access ICT across Cultures: Diversifying Participation in the Network Society* (Proenza, ed., 2015). In 2010, he received DFG research grant, and he spent three months at Chemnitz Technical University in Germany. Currently, he is leading several research projects at the University of Jordan.

Besides teaching undergraduate and graduate course, and supervising many MA and PhD students, Professor Rabab'ah held several administrative positions in Saudi Arabia and Jordan. At the University of Jordan, he served as Assistant Dean for Quality Assurance and Accreditation, and Assistant Dean for Student Affairs (2007-2009), and Chair of Department of Linguistics at the University of Jordan (2014–2015, 2016-2017). At Alfaisal University (Saudi Arabia), he chaired the Department of Humanities and Social Sciences at the College of Science and General Studies (2010 - 2013). On Sabbatical, he worked

as Director of English Language Center and General English Language Supervisor at Al-Ghad Colleges for Medical Applied Sciences, Saudi Arabia (2015-2016).
